

SECRETARY'S REPORT



It is our pleasure to present to you the 52nd Annual Report of MESCO. It had been an eventful year with many new things happening and more people benefiting due to your continued Patronage. With your contribution to MESCO in 2019, we were able to reach out to 5894 Beneficiaries which include 5107 Educational Scholarships, 341 patients were assisted, 219 Sewing Machines were distributed to Empower the women and 227 families were provided Monthly Ration Support. In addition 62,858 patients were serviced through our Clinics.

The lockdown which started since 23rd March 2020 due to spread of COVID-19 pandemic had its effect on the people from the lower strata of the Society, mainly the daily wage earners. We at MESCO believe that we are 'Born to Serve'. Although our Office was also closed, our Warriors carried out relief work and distributed Ration-Kits. We were able to reach out to 1100 affected families.

FINANCIALS

Our total income in the year was INR 9.30 Cr. and INR 1.12 Cr have been received towards Corpus; the expenditure for the corresponding period has been INR. 10.52 Cr. Our efforts to tap CSR fund provided us INR. 42.20 lakhs from 08 corporates which included the likes of Nadiadwala Grandson Entertainment Pvt. Ltd., Indiabulls Foundation, NOKIA, Ocwen Financial Solutions Pvt. Ltd., Wallem Ship Management (India) Pvt. Ltd., Regent Assets Consultancy Services Pvt. Ltd., Talib & Shamsi and Lancer Container Lines Ltd. We continued getting supported by Give India under various listed donation options; the total amount received was INR. 19.03 lakhs. Payroll giving yielded INR. 4.01 lakhs and has potential to increase several folds. Sale of old newspapers, clothes and scarp donated yielded INR. 31.12 lakhs.

MESCO's PROGRAMS & SCHEMES

EDUCATION

MESCO continued its support for the students under various education schemes. These included the general scholarships (2751 under school level, 1393 under college level,71 for technical courses and 94 for short term vocational courses), scholarships for means deprived and meritorious students (522) and scholarships for professional courses (267). What makes us proud is that out of the total 5107 students covered under these various schemes a total of 2588 i.e. 50.68% were girls. Apart from the monetary support to these students,

MESCO also provided some key inputs like, extra financial support for attending coaching classes, Group and individual Counselling, Aptitude Tests, Residential Personality Development Camp and focused lectures and talks. This year special efforts were put in to select students with potential for Civil Services and we provided them coaching to prepare for the UPSC exam.

From the last 22 years MESCO has adopted the R. C. Mahim Municipal School under the MCGM PPP Program. We continued our interventions in the school by proving extra coaching classes at three levels, 8th, 9th and 10th (SSC) grade. Of the students who attended the extra coaching classes, the pass percentage at SSC was 94.7% with one of these students scoring the highest percentage of 90.60% at the exam. MESCO also continued to provide Teachers to conduct regular classes at different levels. We collaborated with Ratna Nidhi Trust to provide free midday meal to the students attending our extra-coaching classes.

MEDICAL AID & CLINICAL SERVICES

We were able to reach out and support 341 patients through our schemes like the High Cost Medical Aid, General Medical Aid, Six Months Dialysis Support, Sustained Dialysis Support & Injection Support. Primary Health Care was rolled out through the three static dispensaries and one mobile clinic. A total of 59036 patients were serviced through our Clinics. In addition specialized care was provided to 3822 patients through Physiotherapy Clinic at Kurla. We are grateful to, M/s Sinkhai Foundation and Americares Indian Foundation for the regular donation of medicines. We also wish to thank Dr. Pokar, Dr. Shetty, Dr. Yasmeen Chataiwala, Dr. Pardeshi, Mr. Suresh Pinto and Mrs. Shabana Kazi for contributing branded and generic medicine to help us in reaching the distressed patients attending our clinics.

This year we collaborated with Star Foundation to provide Medical insurance cards to 125 beneficiaries under the Ayushman Bharat — Pradhan Mantri Jan Arogya Yojna (AB-PMJAY) through which each member would get benefit of upto Rupees Five Lakhs yearly towards medical treatment.

GENERAL AID (POVERTY RELIEF & WOMEN EMPOWERMENT)

We supported 227 families under the monthly Ration Support Scheme. We are grateful to Mr. Farouk Alimahomed and Mr. Faisal Vahedna and several other individual donors who provided financial support. Three Sewing Machine Distribution programmes were held, one each in July, October and December of the year under report where a total of 219 sewing machines were awarded to ladies, who had the necessary ability to help them use these for gainful self-employment. We are grateful to Nokia, M/s Nadiadwala Grandson Entertainment Pvt. Ltd., and Wallem Ship Management (India) Pvt. Ltd. and several other individual donors who helped us give away the



sewing machines to the rightful applicants. We also organized the Iftar Packets Distribution at the behest of the some MESCO well-wishers, particularly Mr. Farouk Alimahomed. Iftar Packets Distribution was organized at Anjuman-I-Islam Girls High School, Mahim and Crescent English High School (Mumbra). A total of 719 packets containing 08 items were distributed from these two locations.

It has been an eventful year and I once again like to extend my gratitude to my fellow Managing Committee Members, my Sub-Committee Members, Advisory Committee Members, my Staff, Volunteers and a sea of MESCO's donors and well-wishers, without all of you we would have not been able to achieve this level performance.

YOUR Support and Prayers have ENCOURAGED us at MESCO to continue the Noble work. We Thank You ALL and request you to continue your financial support so that we can serve more people. We request you all to take care of yourself and your family and Stay Safe. Let us all pray that we are relieved of this COVID-19 pandemic disaster soon and seek the Blessings of the Al-Mighty for the entire mankind. How to change lives with 'raddi'

Can old newspapers, used clothes, metal cans and plastic containers change lives? Turns out, they can. Ask MESCO - Modern Educational Social and Cultural Organisation. This charitable organisation has provided educational aid to 4,162 underprivileged school and college students in 2018-19 by collecting these scrap and using the funds generated from their sale for educational aid.

In 1968, three junior college students of National College,

Bandra - Azhar Ali Qureishi, Abbas Khatkhatay and Saeed Ahmed Vohra came together to help other underprivileged students when they saw that many of their classmates could not afford to pay fees or buy books.

Initially, they sold ice cream and greeting cards to raise funds. It was a wellwisher who suggested the young men to collect old newspapers and sell them to raise funds, as this way the funds would come in regular-

In the first year, they had managed to get just Rs 250 from collecting and selling old newspapers. Today, the NGO's newspaper collection unit has over 3,200 donors across the city, its suburbs, Thane and Navi Mumbai. Money generated from selling these is used to provide books to school and college

The NGO makes the best use of scrap they receive. Even used toys are collected and kept in nurseries that the organisation runs. Scrap such as wedding cards are used by teachers in these schools to make teaching-aid material and craft, games and puzzles

The organisation's newspaper collection teams had collected over 1,80,000 kg of old newspapers last year. By collecting over 41,000 kg of used clothes and other recyclable scrap, the organisation generated over Rs 7.5 lakh. People can also donate academic and pleasure-reading books, which the NGO keeps in the library of a school it runs in Mahim.

By newspaper collection, the organization generates Rs 30 lakh annually, but of that, says its General Secretary Prof. Makba Farhaan, that it manages to get a net profit of only Rs 5 lakh on account of the operation cost of the collection vans and staff

A young scientist's leap from Kurla slum to Virginia

TIFR scientist Jaykumar Vaidya's research papers in reputed international journals earn him a PhD offer from the Universtiy of Virginia; his is an inspirational tale of grit and sweat

potholed lane lined with garbaga leads to a small room in a Kurla slum. This is the house of 24-yearold scientist Jaykumar Vaidya, an ex-TIFR researcher whose grit and hard work have earned him a ticket out of his impoverished life. Vaidya will fly to the US today, where he will pursue his PhD at the University of Virginia. Whileworking at the Tata Institute of Fun-

damental Research (TIFR) as junior research associate, Vaidya published two scientific pa-pers in reputed international journals in 2017 and 2018 based on which the University of Vir-ginia invited him to join them as graduate research assistant.

Vaidya's journey-that began in one small room in Kurla - is full of such milestones. As a child he was raised by a single mother, Nalini, who was first banished from her marital home and later got divorced from her husband. She gave up her clerical job in 2003 to take care of her mother and worked several small jobs to make ends meet. Besides, she juggled court datesforthedivorcecasethatlastedninewars

Poverty threw a siew of challenges before Vaidya and his mother. "We survived on vada pay, samosa or chai and bread. There was no such thing as lunch or dinner. When we came back home by the end of the day, we ate," he told Mirror at his residence.
Atemple trust provided some provisions to

the family and till today the mother-son duo wears second-hand clothes. Arefrigerator and TVinthecramped roomare also second-hand acked to capacity, this 75 sq ft room is where Vaidva studied for school and an engineering

There was neverany money. I neverwent to school picnics, to eat outside with friends, to hang out or for movies. By the end of the month, we had less than Rs 16," he recalled. The desire to be come a scient ist germinated after watching Discovery channel at other people's homes. "There was always the hope that there is the next day; and that the next day would be better. I believed that everything is possible if you are patient, optimistic and hardworking," he said.

Vaidya's mother recalled, "I told him he

would have a better life if he studied. I routinely got letters from school asking me to pay the fee or they would not show the results." she said, adding that the family went from pillar to post seeking help from various trusts. Some but seeking help from volus titos, some brutally advised Nalini to make her son a driv-er. However, steady funds from the MESCO Trust and the Indian Development Founda-tion (IDF) gavewings to Vaidya's dream of pursuing studies. To augment fund flow, Vaidva undertook soldering work at a TV repair shop when he was in school; this got him Rs 4,000 a

Vaidva graduated in electrical engineering from KJ Somaiya College of Engineering Whileincollege, he bagged three national-levelandfourstate-levelawards in robotics which earned him an internship at Larsen & Toubro. After graduation, he joined TIFR in 2016 for a monthly salary of Rs 30,000.

"I could finally renovate my house. It was infested with insects, the floor had no tiles and the bathroom was leaking," he said. He recentlybought an air-conditioner as well.

Vaidya put in his hard-earned money to take GREand TOEFL tests. While the University of Virginia has offered him an annual sti-pend of \$ 23,400, the application and visa process have burnt a hole in his pocket. To keep afloat, Vaidya started teaching international students online. A white board framed on the wall above the bed is where he solved complicated equations standing and perched his phone on a wooden stand nailed to anoth-

Vaidva plans to work on solutions that will make India self-reliant in the hardware technologies. In the next two years, he plans to bring his mother to the US, as "shedeserves the heaven,"he said.

"Vaidva's work over the last three years propelled him for the PhD programme. He is an unusually hardworking person and I have not seen many like him," said Prof Mandar M Deshmukh from TIFR, who was Vaidva's men-

MESCO has developed several Educational Schemes to bring about a change to improve the society and curtail the dropout rate of students and encourage them to pursue their dreamed professions.


EDUCATIONAL AID (EA)

In the year **2019-2020** the organization has assisted **2751** students at School and **1393** students at College Level under Educational Aid Scholarship programme. The organization assisted **71** students under Educational Aid Technical (Scholarship) and also **94** students who took Short Term Vocational Courses like Electrician, Computer Hardware & Networking and Fashion Designing at the MES Vocational Training Centre.

EDUCATION ADOPTION SCHEME (EAS)

It is one the flagship programme of MESCO which is based on merit cum means where the academic excellence along with financial condition is taken into consideration. In the year 2019-20, there were **522 students** under the Education Adoption Scheme.

The organization believes in the holistic development of the students, hence multidimensional activities are carried out throughout the year like Personality Development Camp, Orientation Programme, Educational Programme, Aptitute Test, Engineering students Get-together, Graduating Students Get-together, Career Guidance, Counseling etc.



HIGH COST EDUCATION SCHOLARSHIP (HCES)

In the Educational sphere, the demand for the professional courses increases with ever increasing cut throat competition in the market. These lead to the elevation of unbeatable course fees which is beyond the reach of middle class family. The primary aim of this scholarship programme is to support talent based on certain percentage criteria and meet the financial requirement of that section of students who are academically bright but financially underprivileged. In the year 2019-20, 276 students were under the High Cost Education Scholarship (HCES). Students assisted for various courses under the scheme were 86 -Medical, 144 - Degree in Engineering, 8 - Diploma in Engineering, 9 - Business Management, 8 - Hotel Management, 1 - C.A., 15 - B.Ed & D.Ed, 1 - Graduation and 4 - Post Graduation.

EDUCATION PROGRAMS

Education Programme for Std. X & Std. XII titled "How to prepare for Exams" was held on 24th November 2019 at Anjuman-i-Islam Girls High School, Bandra. There were total 183 (107 students and 76 parents) who attended the programme. Ms. Netra Kher from Disha Foundation emphasized on "How to prepare for Exams" and the second resource person Mr. Ahsan Sayyed, (Motivational speaker) threw lights on the different scholarship programmes (Government as well as Private Scholarship). Our student Master Mehboob Mondal (pursuing 2nd Year MBBS from J.J. Medical College) shared his experience of preparing for NEET Examination. "Edu Guide" a booklet comprises of different courses detail, scholarship detail, different examination detail etc. was distributed to the students.

Top Ranking Students' Felicitation Function of MESCO was held on Saturday, 4th January, 2020 at Y B Chavan Auditorium from 3.00 p.m. onwards.

Mr. Prof. Abbas Ali Gabula, Associate Director external relations of one of the top 5 business schools in the country SPJIMR graced the occasion as Chief Guest. Other Guests of Honor present were: Mr. D. A. Chougule (Renowned Social Worker), Mr. Ali Qureshi (Trustee, AFMI), Mr. Aslam Shah (Chairman and MD of Arabia Sea Engineers India), Dr. Prerna Sharma (Faculty at School of Vocational Education, TISS). Mr. Mehernosh Dordi (COO of the Tobaccowala Foundation), Dr. Aslam Abdullah (Editor-in-Chief of Muslim Media Network Inc.), Mr. Asgar Shaikh (Head of Resource Management, L & T one of the top 6 Indian IT services company), Nisreen Ebrahim (CEO of the RF (I) T) and Mr. Biju P.K. (Assistant Registrar Income Tax Appellate Tribunal Mumbai Benches).

COUNSELLING & MENTORING: Group Counselling was organized for 65 H.S.C and 30 S.S.C students after their results in the month of June 2019. In the reporting year 362 individual

counseling sessions were done for Secondary students (VIII to X), 468 sessions with Junior College students (XI & XII), 446 sessions with Graduation students, 22 sessions for Post-Graduation students, 73 sessions for Engineering students (Diploma & Degree) and 56 sessions for other categories. Students of Std IX & XI were also part of the Mentoring Program conducted by the Education Department. In the reporting year a total of 85 such students were provided mentoring support.

APTITUDE TEST SESSION: Aptitude Test Session was conducted on 28th and 30th October 2019 at Anjuman I Islam Girls High School, Bandra. Total 99 students appeared for the same.

PERSONALITY DEVELOPMENT

This was the 20th Camp which was held at St. Pius, Goregaon from 26th December, 2019 to 28th December, 2019. Total **47 girls** were present for the camp. Right from the beginning, these Camps have been proved a boon for the personality development of the students of MESCO. During these three days students were given several inputs through sessions on various topics such as Time Management & Goal Setting, Communication Skills, Ethics, Leadership, Attitude and Grooming, Group Dynamics and Team Building, Personal Health and Hygiene, Stress & Conflict Management, Motivation and Social Responsibility etc.

INDUCTION AND ORIENTATION PROGRAMME: An induction and orientation of **161** new EAS students was held at the office in batches. The student's details are as follows: Secondary – **121**, Junior College – **34**, Graduation – **03**, Diploma – **01 and** Degree - **01**.

DONOR – STUDENT MILAP: The 12th Annual donor and student (beneficiary) Milap programme was held on **3rd& 17th November 2019** to have an interaction between the sponsored EAS and HCES students and their respective sponsors. It was attended by **148** students and **34** donors.

ENGINEERING STUDENTS' GET – TOGETHER: Organized on Sunday, 8th March 2020 at Karimi Hall, Anjuman-I-Islam, CST. The Enlightening Session on "Campus to Corporate "was conducted by Mr. Zulfiqar Syed, Manager, Mastercard and his team. The session was on "Employability" by Mr. Asgar Shaikh, Head of Resource Management (L&T) to brief the students nitty gritty of Employment. There were total 123 audiences out of which 108 students, 05 parents, 05 Committee Members and 05 staff members.

EX-STUDENTS GET-TOGETHER: Ex-Students' Get-together was held on Sunday, 8th March 2020 at Karimi Hall, Anjuman-I-Islam, CST. There were total **72 participants** (**61** Ex-Students, **8** Committee Members and **3** staff Members).

"There is always light at the end of the tunnel"

Jovita D'souza came from a family of four, mother, father and a younger sister. From the school days, Jovita was keen on studying and always scored good but had difficulty in paying fees. When she scored 74% in HSC and wanted to pursue Pharmacy which costs more than 5 Lakhs for 4 years, her family was in dilemma, how they will manage the fees as the only earning person was her father who was a private driver with less income and with that income they were already managing food expenses, all bills, her sister's college fees and mother's medication expenses who is a diabetic patient, all with one man's income.

In the first year she somehow managed to pay the fees by taking loan from her cousins but was always in constant pressure, how she will manage rest three year's fees. Her father suffered Paralytic attack due to stress of paying the fees. In hope of still finding a way, she searched on internet and found MESCO and then MESCO enrolled her in its High Cost Education Scholarship (HCES) in 2016.

As she says..."I was welcomed with respect by all staff members of MESCO right from the security guard to the Head of the Organization. MESCO has helped me to study without worrying about my fee. I'm grateful that MESCO gave me an opportunity to pursue my career of choice and made me an independent individual to also support my family".

Today she is working as Medical Business Associate in GlaxoSmithKline Pharma Company.

MEDICAL SERVICES

The Medical Aid Department at MESCO focuses on providing Financial Assistance to the poorest of the poor and the needy sections of the society since 1976. The assistance is provided through schemes like the High Cost Medical Aid, General Medical Aid and the Dialysis Schemes (06 months support and sustained dialysis support). MESCO collaborated with Star Foundation and provided Ayushman Bharat – Pradhan Mantri Jan Arogya Yojna (AB-PMJAY) cards to 125 beneficiaries to get cashless assistance of upto Rs. 5 lakhs yearly towards medical treatment in any Govt. Hospitals & empanelled private healthcare setup.

HIGH COST MEDICAL AID: Through this scheme, financial aid is provided to the poor and deserving patients, who are suffering from various medical/surgical conditions from PAN India but being treated in Mumbai and Suburbs Municipal and Government hospitals. In the year 2019-20 the department helped 120 Cases.

GENERAL MEDICAL AID: Under this scheme, aid is provided to the poor and deserving patients who require help for medicines, minor surgeries, diagnostic procedures and provision of medical appliances (prosthesis). Under this category 152 cases have been assisted in the year 2019-20.

SIX MONTHS DIALYSIS SCHEME: The patients undergoing dialysis are financially assisted under this scheme for Six Months. The needy patients are selected for assistance on the basis of lottery in presence of all the applicants to maintain transparency. A total of 47 patients were assisted in the reporting year.

SUSTAINED DIALYSIS SUPPORT: This scheme was started in 2012-13, where a life time financial support is being provided to highly deserving cases for dialysis and injection cost. The organization assisted 16 patients under the scheme during reporting year.

INJECTION SUPPORT: 06 patients supported with life time Injection cost for dialysis.

"Never lose HOPE. Storms make people STRONGER and never last forever"

Mr. Shah Ashfak Ahmed aged 30 years male is a case of Chronic Renal Failure did not expect that kidney disorder would take a sudden toll on his health, further leading to financial instability. He undergoes 03 dialysis per week i.e. 12 dialysis p.m. at Rehbar

Foundation's Malik Rakiya Khatoon Dialysis Centre, Govandi. His family lives in their rented house with 02 school going children and paying Rs. 1900/- per month rent for a deteriorated house. Ashfak has been doing jari work at home, earning a meagre income of approx Rs. 5000/- per month. This now became difficult for him as his health didn't support tedious work. But his wife continued to help him such that their other monthly expenses could be managed. Ashfak approached MESCO for assistance, which resulted in a positive response for him.

He was supported with the Dialysis Support scheme. Keeping in mind the expense of school going children in his family, MESCO extended further support to his Children under Education Aid Scheme. The family is very grateful to MESCO for providing extensive financial help in their time of need.


CLINIC & DISPENSARIES

MESCO initiated quality healthcare services through mobile and fixed primary care centre's to underprivileged section of society living in urban slums. Mission is to provide primary care centre's with qualified professionals, where the population has no access to quality healthcare services. First Mobile health unit was initiated in year 2007 and subsequently additional mobile health units and static dispensaries came into existence due to the wholehearted support from our donors. All the curative services and medicines are provided at the clinics with nominal registration fees.

The fixed dispensaries operate in Malad-Malwani (Near Ambujwadi slum), Kurla (Quraish Nagar) and Mumbra (Thane). Our only mobile clinic provides services at 04 different locations in Kausa-Mumbra, visiting each location thrice a week to ensure that patients get treated and are followed up on a continuous basis.

Free BMD, BMI & Hemoglobin check-up Camp with the support of MEYER Vitabiotics was organized at Kurla Dispensary on 1st & 3rd December, 2019. Total 80 patients attended the camp. Another Free BMD, BMI & Hemoglobin check-up Camp with the support of MEYER Vitabiotics was organized at Mumbra Dispensary on 15th December, 2019, which was attended by 76 patients.

We would like to extend our gratitude and thanks to our donors and organization like Sinkhai Healthcare Ltd. (Medley Pharmaceuticals Ltd.), Americares India Foundation for their support. RELIEF OF POVERTY

SEWING MACHINE DISTRIBUTION

One of the income sources for Widows, Deserted and Poor ladies are to stitch cloth and earn money for their family. MESCO has been distributing Sewing Machines to widows, Destitute and Orphan ladies for their livelihood. MESCO is distributing on the basis of their financial condition and also after taking their trade test and interview for final decision. In the year 2019-2020 MESCO distributed 219 Sewing Machines.

RATION SUPPORT

The basic need of a human being is food MESCO provides Ration Support to Widows, Deserted and very old people not having family. MESCO provides the following item mentioned below to 227 families every month: Rice, Wheat, Sugar, Tur Dal, Masoor Dal, Oil, Tea Powder, Chana.

DISASTER RELIEF

MESCO also help the families suffers from natural calamities like riots, floods, fire etc. MESCO contributed INR. 1,50,000/- to Zakat Foundation of India towards donation for Delhi riots victims under Disaster Relief.

IFTAR PACKET DISTRIBUTION

With the courtesy of our well-wisher Mr. Farouk Alimahomed and Mr. Faisal Vahedna, last year MESCO distributed 719 packets to poor and needy fasting Muslims in Mumbai and its Suburbs. Iftar Packet Distribution was held on Saturday 4thMay 2019. 536 packets were distributed from Anjuman-I-Islam Girls High School, Mahim and 183 packets were distributed from Crescent English High School for Mumbra.

DETAILS OF THE SEWING MACHINE DISTRIBUTION PROGRAM

The First cycle Sewing Machine Distribution Programme was held on Sunday 30th June 2019 at Bandra Boys Urdu High School. Ms. Asha Mehta – Trustee – Ratna Nidhi Charitable Trust graced the occasion as Chief Guest. Ms. Jyotsna Mody – Project Manager – Ratna Nidhi Charitable Trust accompanied with the Chief Guest. Few Beneficiaries shared their experience in the programme. A total of 56 Sewing Machines were distributed on the occasion. The fourth cycle of Sewing Machine Distribution Programme was supposed to be held on Sunday 29th March 2020 at Bandra Boys Urdu High School. Due to COVID-19 pandemic and country-wide lockdown the program was put on hold. Once the lockdown is over we will conduct the Trade Test and distribute Sewing Machines to the eligible candidates.

Rukaiya Shaikh was 50 years married women and her husband was working as a hawker on the street but his income was not stable as he was facing problem from municipality. Rukaiya had to start stitching at home to contribute to her family income and she was able to earn Rs. 2000-3000/- monthly but that income was not sufficient to manage household expenses and also education was needed for her 3 children. She had approached MESCO for ration support as one of her child Sadiya was an EAS student of MESCO and was getting help under the scheme from VIII onwards. MESCO willingly assisted the family so that the family can utilize their income for education of their children. She started receiving ration support since 2011 onwards. Gradually financial status got improved and her both daughters got married.

Shaista- XII- married 12 years back. Sadiya — B.com married 4 years back. Sadiya was an EAS student of MESCO from VIII till Graduation and she was taking part time tuition after completion of her studies for some time. Md. Salim son of Rukaiya completed B.Com. and is currently working as an IT Engineer in Dubai for past few months and earns Rs. 25000/p.m. He also worked in Mumbai for 02 years. Family has voluntarily discontinued since January 2020. The entire family has expressed their gratitude and is obliged that they have received ration support from MESCO in their real testing time and in the period where they really needed support to sustain themselves.

R. C. MAHIM MUNICIPAL SCHOOL

MESCO adopted the school on 26th November 1997 under the partnership with the MCGM (Educ. Dept.), trying its best to uplift the standard of R. C. Mahim Municipal School. It had total student strength of 980 students in the reporting year. The SSC passing percentage was 94.70 % with highest student percentage of 90.60% in the current year.

MESCO arranged the lectures for the SSC students in the subject like Maths, English, Marathi, Science & Urdu. MESCO also provided study material to SSC students for better performance in the board examination. In addition to conducting Extra Coaching Classes for secondary section (STD VIII, IX & X) Midday snacks were provided daily to 280 students who attend the extra coaching class. We also conduct P.T.A meeting from STD VIII to STD X. Apart from this MESCO also provided teachers and clerk in regular school. MESCO conducted Sports Day, Annual Day, Urdu Day, and Farewell for S.S.C. students & Felicitation Programme for S.S.C. & D.Ed. Students and also conducted Counseling Lectures, Motivational Lectures and Expert Lectures, career guidance lectures for the students. In terms of sports, students were encouraged by providing facilities such as: Carom, Chess, Volley Ball, Cricket, Badminton etc. we also provided Navneet 21 set for Xth STD students to achieve more marks in SSC board examination. We also conducted study camp for SSC students for their guidance. Notebooks and stationary provided to all from primary to D. Ed. College.

Every 2nd and 4th Saturday of the month we conducted many activities like writing competition, Drawing Competition, Mehendi Competition etc. We also organized different kind of Events such as Annual Day, Felicitation Function, S.S.C. Farewell, Urdu Day etc. to inculcate the moral value among the students. Iftaar packets were also distributed to all needy students during the month of Ramadan. Art exhibition was conducted by the D.El.Ed Students. They also received support from MESCO to do MS-CIT course for having good knowledge of basic computers

and also conduct field visit for D.El.Ed college students.

Annual Felicitation Function was held on 22nd November 2019, at R C Mahim School. Std. X & D.E.I.Ed students participated in this event. The occasion was graced by Mrs. Mamta Rao (Deputy E.O – Secondary Section) as Chief Guest. The Guest of Honor included Mrs. Snehalata Dumre (A.O. Primary), Mrs. Nasreen Arzoo (B.O – Secondary Section) D.EI. Ed Incharge – Mr. Ahmed Shah, Secondary Incharge – Mrs. Zubaida Khan, Primary Incharge – Mrs. Latifa Baig, Chairman – Mr. Salman Kardame along with other Committee Members. 17 students of S.S.C. and 03 students each of 1st& 2nd year of D.EI.Ed College were felicitated. College Bags and Certificates were distributed to 1st, 2nd & 3rd Rankers in both S.S.C. and D.EL.Ed students.

MESCO also collaborated with Ratna Nidhi Trust to provide free midday meal to the students attending our extra-coaching classes.

NEWSPAPER COLLECTION

The Organization has been carrying out this activity since its inception. A classic example of how "each drop of water can make an ocean". In the reporting the organization collected 67988 kgs. Of Old newspapers through the **City Unit** (Bandra to South Mumbai & Chembur), 75915 kgs. Of Old Newspaper through **Suburb Unit** (Khar to Borivali) and 33085 kgs. Of Old Newspapers from **Thane Unit** (Thane, Navi-Mumbai & Mira Road). Apart from this three Units were able to collect 39304 kgs. of Old Clothes and generate INR. 365246/- by the sale of various scrap items. We are thankful to the 3100+ donors, spread across 64 locations (3145 houses/units across 1625 housing societies & 15 institutional units) who have been supporting us and helping us carry out this activity year after year. Your contributions have aided in the growth and development of many students.

NOTES FORMING PART OF ACCOUNTS AS ON 31-03-2020 SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING:

- 1) The financial statements have been prepared in accordance with the historical cost convention in accordance with the generally accepted accounting principles in India and the applicable Accounting Standards issued by the Institute of Chartered Accountants of India.
- 2) All Income and Expenditure items in the financial statement are recognized on accrual basis.
- **B.** <u>USE OF ESTIMATE:</u> The preparation of the financial statements are in conformity with the significant accounting policies which require the management of the trust to make estimates and assumptions that affect the reported amounts of income and expenditure of the reporting period and the reported amount of assets and liabilities as on the reporting date. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods.
- C. <u>PROPERTY PLANT EQUIPMENTS (PPE)</u>: PPE are stated at cost of acquisition, less accumulated depreciation. The cost of PPE includes the purchase cost of PPE and any other directly attributable costs of bringing the assets to their working condition for the intended use.
- **D.** <u>DEPRECIATION:</u> Depreciation is provided on the PPE under the written down Value method at the rates and in the manner prescribed by Income Tax Act, 1961 & has been charged to the Income and Expenditure Account.
- **E.** <u>INVESTMENTS:</u> Investments of the trust comprise of fixed deposits with banks and Mutual Funds stated at cost.
- **F.** <u>REVENUE RECOGNITION:</u> Donations are recognized on receipt basis. Donation received with a specific direction that they shall form part of the Corpus Fund of the Trust has been accounted accordingly. Interest income is accrued on a time proportion basis having regard to the amount outstanding and the rate applicable.
- **G.** Figures for the previous year have been regrouped and reclassified wherever necessary.


