SECRETARY'S REPORT

DEAR MEMBERS AND WELL-WISHERS

I am honored to present the 56th Annual Report of MESCO. The year 2023-24 has been eventful, marked by numerous new initiatives and an increased number of beneficiaries, thanks to your ongoing support. MESCO was able to extend its reach through educational scholarships, medical aid, and the provision of sewing machines to empower women. Additionally, families received Monthly Ration Support, and patients were served through our clinics. MESCO also organized staff training programs focused on the well-being and skill development of our employees.

FINANCIALS

Our total income in the year was INR 14.22 Cr. and INR 90.70 lakhs have been received towards Corpus; the expenditure for the corresponding period has been INR. 12.82 Cr. Our efforts to tap CSR funds provided us INR. 33.90 lakhs from 06 corporates.

We continued getting support by Give India under various listed donations options, the total amount received was INR 12.75 lakhs. Payroll giving yielded INR 10.54 lakhs. Sale of old newspapers, clothes and scrap donated yielded INR 38.89 lakhs.

EDUCATIONAL SUPPORT PROGRAMMES

MESCO provided Education Scholarships to students through various scholarship programme in the year 2023-24:

- 1. Education Adoption Scheme:** Supported **622** students.
- 2. High Cost Education Scholarship:** Provided financial assistance to **263** students pursuing professional courses.
- 3. Educational Aid (School Level):** Supported **3,305** students.
- 4. Educational Aid (College Level):** Assisted **1,553** students.
- 5. Educational Aid (Technical):** Supported **100** ITI students.
- 6. Short Term Vocational Courses:** Assisted **65** students enrolled in short-term vocational courses.
- 7. Study Centre:** We are pleased to announce that MESCO has come up with a new venture. We have inaugurated a Study Centre in Mahim, on 10th November 2023. The centre aims to provide valuable educational support to needy students in the area.

The total outlay on Educational Scholarships for the financial year 2023-2024 was INR 8.25 Crores serving a total **5,908** students.

INSTITUTIONAL SUPPORT

In addition to scholarships, MESCO adopted **R.C. Mahim Municipal Urdu School**, which has 920 students, and spent INR 22.32 lakhs on educational activities in FY 2023-2024. Due to MESCO's extra classes, the SSC result was 100%. MESCO also adopted **Parekh Nagar Municipal School** in Malad (E) on 26th December 2023, in partnership with MCGM. The school, with **807** students, covers all education levels. Additionally, MESCO has recently partnered with MCGM to adopt **Bandra Petit Municipal Urdu Secondary School** in Bandra (W).

MEDICAL AID & CLINIC SERVICES

We were able to reach and support **725** patients through our Medical schemes such as Life-Saving Medical Aid, Medical Aid, Six-Months Dialysis

Support, Sustained Dialysis Support and Injection Support. In 2023-24, we spent INR 2.51 crores in medical interventions schemes. Primary health care was rolled out through 02 static dispensaries. A total of **16,065** patients were treated at our clinic at Mumbra, and **1,324** patients received specialised physiotherapy treatment at our Physiotherapy centre at Kausa.

We thank the Donor Mr. Imran Contractor, M/s. Nadeem Foundation, M/s. Tobaccowala Foundation, Mr. Faisal Yusuf Vahedna, M/s. RCF and many others for their generous donations for the treatment of needy and very deserving patients.

RELIEF OF POVERTY

MESCO continued to provide monthly food support to **466** families through the Ration Support Scheme. The commitment towards women empowerment continuous and organization was able to distribute **112** Sewing Machines in the year 2023-24 to widows, destitute, deserted and needy women unable to manage the basic family needs. MESCO spent INR 1.32 Crores under ration support and sewing machine schemes for the F.Y. 2023-2024.

During the blessed month of Ramadan, our efforts took on an even more touching dimension. In a heartfelt endeavor, MESCO distributed **1070** Ration Kits to the needy and deserving souls who observed fasting throughout the day. The warmth of these gestures resonates deeply within our hearts.

DISASTER RELIEF

Following the demolition of over 200 huts in Ambujwadi, Malad on 20th July 2023, MESCO provided immediate aid to displaced families, distributing **830** food packets and **250** water bottles. This effort underscored our commitment to supporting vulnerable communities, with ongoing efforts to rebuild lives and advocate for lasting solutions.

As we conclude, I offer a heartfelt prayer to the Almighty, asking for His blessings on our collective efforts and all those who have stood by us—our Donors, Supporters, Well-wishers, Volunteers, Ex-students, and the dedicated members of our Committee and staff. Together, we have achieved remarkable things, yet there is still much more to be done. We continue to seek more helping hands to extend our reach and support even more lives in need.

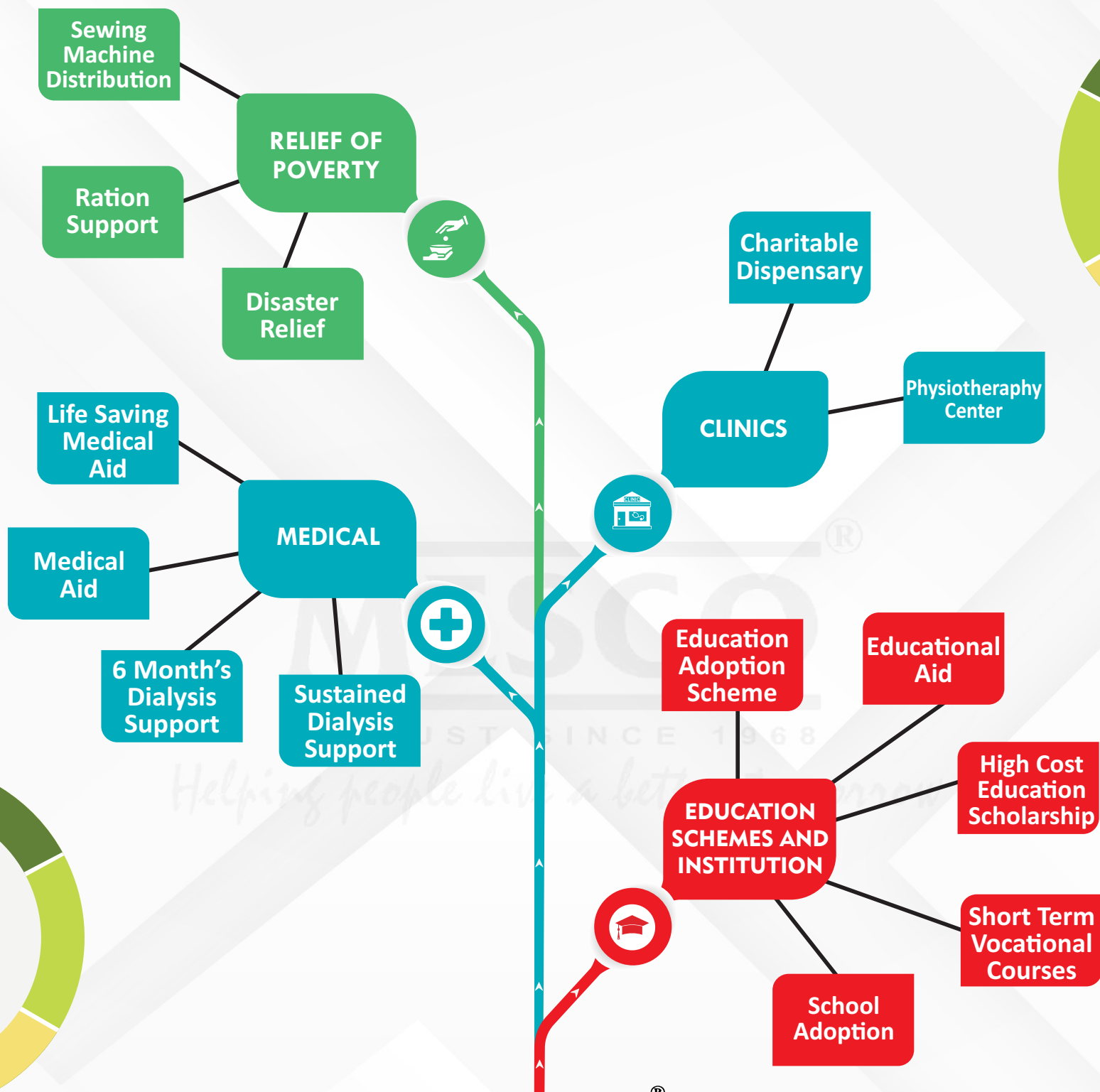

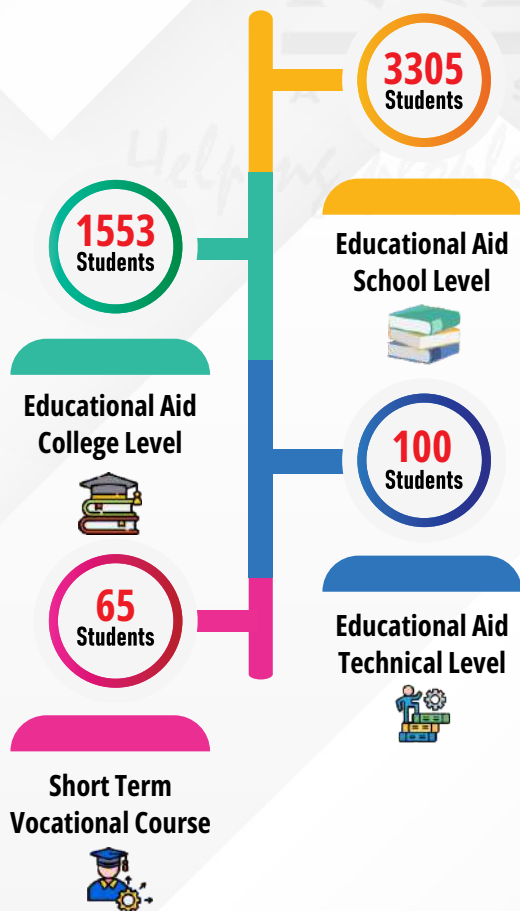
EDUCATIONAL SUPPORT PROGRAMMES

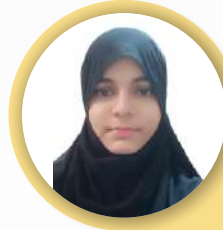

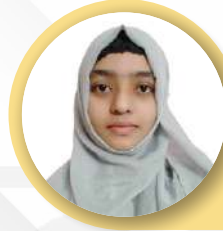

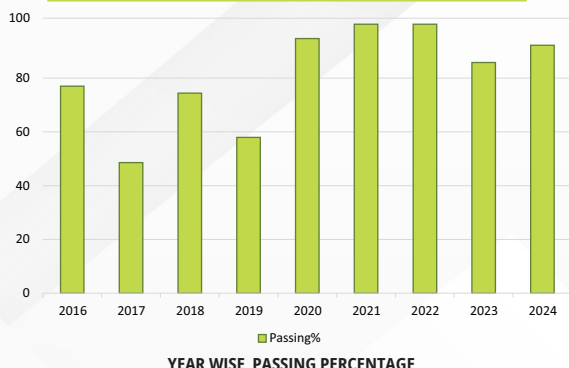
SCHOOL ADOPTION

R.C. MAHIM MUNICIPAL SCHOOL

- Since MESCO adopted R.C. Mahim Municipal School on 26th November 1997, in partnership with MCGM (Education Dept.), it has consistently worked to improve the school's standards. The school currently has around 920 students, and the SSC passing percentage this year is 92.18%.
- Throughout the year, MESCO organized lectures for SSC students in subjects like Maths, English, Marathi, Science, and Urdu, and provides study materials to enhance their board exam performance. Extra coaching classes for 9th and 10th graders include daily mid-day snacks for 200 attendees. Regular parent meetings are also held for these students.
- In addition to academics, MESCO organizes events like Urdu Day, SSC Farewell, and Felicitation programs for SSC and D.El.Ed students. Motivational, Career Guidance, and Expert lectures are also conducted. Sports facilities such as carom, chess, volleyball, cricket, and badminton are provided. SSC students were provided Navneet practice papers and participated in study camps. Notebooks and stationaries are distributed to all the students.
- After SSC, MESCO supports students with further studies, scholarships, and ration assistance to prevent dropouts. Activities like Writing, Drawing, and Mehendi competitions are held Bi-monthly to foster a sense of belonging and encourage attendance. Events like Felicitation Functions, SSC Farewell, and Urdu Day help instill moral values. Iftar packets were distributed during Ramadan.
- MESCO also provides teachers for secondary school, a caretaker, and supports students in pursuing MS-CIT computer courses. For primary students, MESCO distributes water bottles, notebooks, and crayons, and organizes competitions, sports days, and a FUNFEST with prize distributions to motivate and recognize their talents.

PAREKH NAGAR MUNICIPAL SCHOOL

MESCO received permission to adopt a school in Kurar Village, Malad (E) on December 26, 2023, in partnership with MCGM (Education Dept.). The school, with approximately 807 students, includes Pre-Primary, Primary, and Secondary sections, with the Primary section operating in two shifts. MESCO is committed to uplifting the school's standards by conducting Counselling and Guidance lectures for SSC students. MESCO also organized felicitation program, and distributed exam kits to SSC students. Notebooks were given to 9th and 10th-grade students. The Iftar packets were provided to the needy students during Ramadan.



MEDICAL SERVICES

The intersection of health and financial assistance for medical patients has become increasingly critical. Many individuals and families face dire financial strains due to medical expenses which results in financial instability and hardships. MESCO recognizes the profound impact of such challenges and remains determined in our mission to provide crucial financial aid and support to those in need. The schemes at MESCO have been designed to cater various types of requirements of the patients.

LIFE SAVING MEDICAL AID

390 patients were supported for the various planned surgeries related to cardiac, kidney, brain and orthopaedic, Cancer treatments, immune system deficiencies treatment, Cochlear implant and hearing aid etc. These are patients referred from various Municipal and Government hospitals located in Mumbai.

MEDICAL AID

264 patients were supported for various minor treatments and surgeries, diagnostic procedures and monthly medicines for the chronic ailments.

SIX MONTHS DIALYSIS SUPPORT

61 renal failure patients were supported for their 06 months dialysis cost.

SUSTAINED DIALYSIS SUPPORT

10 renal failure patients supported for their annual dialysis cost.

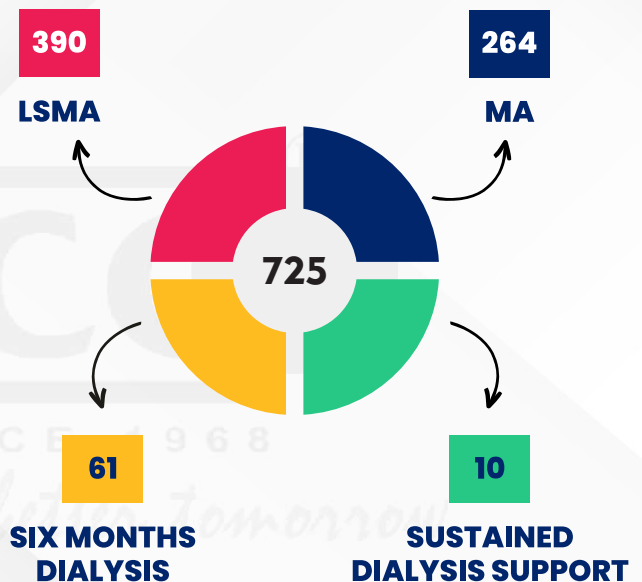
ACHIEVEMENTS AND PROGRAMMES

- MESCO has received a prestigious award and certificate from Nair Hospital for helping needy patients in their treatment on October 12, 2023.
- A free medical camp was held in Govandi area on 30th, April 2023, benefiting a total of 170 patients.
- Free Health Check-up camp was organized at Imamwada compound Mumbai-9, on 7th January 2024. A Total of 223 patients availed the benefit through the medical services provided at camp.
- Free Health Check-Up Camp was organized at Radiant School on Sunday, 18th February 2024. We were able to serve a total of 680 patients in the camp through our team of doctors.
- Health Awareness programme regarding kidney disease was held on 18th February 2024 at Radiant School, Mumbai. Nephrologist Dr. Pooja Binani conducted a session on "Detection and Prevention of Kidney Disease," while Dietician Ms. Sana Sarang Shaikh discussed "Diet Management in Chronic Kidney Disease and Renal Failure."

GRATITUDE STORY

At just one year old, Dhairya was diagnosed with congenital heart disease, a diagnosis that shook his parents to their core. His father was an office boy earning Rs. 12,000 p.m and his mother struggled to make ends meet in their rented house in the slums of Diva. The costly cardiac surgery recommended by Wadia Hospital was beyond their means. Despite efforts to gather funds, they still fell short. Their prayers were answered when MESCO stepped in, providing the remaining balance needed to complete Dhairya's surgery. This lifeline ensured that Dhairya could undergo the crucial operation. Today, Dhairya lives a normal, healthy life experiencing the joys of childhood just like any other child of his age.

Dhairya's parents are deeply thankful to the MESCO for the generosity shown to them during their darkest hour. Their gratitude is a tribute to the kindness that transformed their nightmare into a story of hope and renewal.

CLINICS DEPARTMENT

MESCO is dedicated to providing primary health care with qualified professionals in areas where access to quality health services is limited. The Medical-Aid Dispensary, initiated in 2010 in Amrut Nagar (Mumbra), operates in memory of Mohammed Yusuf A. S. & Mohammed Ghazi Vahedna, with the support of Mr. Faisal Vahedna. The dispensary is open from 11 am to 10 pm (11 hours) every day except Sundays and selected holidays.

On May 2, 2023, the "Umair Khopekhar Memorial Clinic" reopened at the Umair Khopekhar Memorial Physiotherapy Centre in Kausa, operating from 6:00 pm to 9:00 pm. The centre supported by Mr. Tanveer Khalfay and the Khopekhar family.

Our centers provide primary health care for a nominal fee and treat common illnesses. The patient footfall at our Clinics in 2023-24 are as follows.

HEALTH CAMPS

- On 5th November 2023, Umair Khopekhar Memorial Clinic & Physiotherapy Centre organized a Free Medical Check-up Camp. The camp provided free Medicines, Bone Mineral Density (BMD) tests, Random Blood Sugar (RBS) checks, and Physiotherapy check-ups. A total of 123 patients participated in the camp and received free medication after consulting with our doctor. Additionally, 38 patients received physiotherapy examinations, with 17 of them being selected for one-day free treatment. BMD was checked for 77 patients, and Random Blood Sugar was tested for 38 patients.
- On 24th December 2023, a Free Medical Check-up Camp with complimentary Optometry tests, Random Blood Sugar and Blood Pressure check-ups was organized at the Medical-Aid Dispensary in Amrut Nagar, Mumbra. A total of 121 patients participated in the camp. 78 patients received optometry examinations and 35 of them were provided with eyeglasses at a subsidized rate of Rs. 120/- each. Additionally, 61 patients had their Blood Pressure checked, and 63 patients were tested for Random Blood Sugar.
- We extend our heartfelt thanks to all the donors and organizations, including Medley Pharmaceuticals Limited. Our gratitude also goes to Dr. Pokar (Bhiwandi), Dr. Yasmeen Chataiwala (Mahim), and Mrs. Shabana Kazi (Dockyard Road) for their consistent donations of medicines.

SEWING MACHINE DISTRIBUTION

The Sewing Machine Distribution Program by MESCO empowers women in need, including widows, destitute women, and orphans, by providing sewing machines to foster self-reliance and improve livelihoods. These machines symbolize economic independence and resilience.

In the fiscal year 2023-2024, MESCO distributed **112** sewing machines to deserving women after a careful selection process. This process included assessing financial conditions, conducting trade tests, and holding personal interviews to ensure recipients were truly in need and capable of using the machines to better their circumstances.

1st Cycle Distribution (Saturday, 24th June 2023): 23 sewing machines were distributed with generous support from donors, marking the beginning of the journey towards self-sufficiency for many women.

2nd Cycle Distribution (Sunday, 8th October 2023): 36 sewing machines were distributed, amplifying the impact of the program with contributions from sponsors and individual donors.

3rd Cycle Distribution (Saturday, 23rd December 2023): 22 sewing machines were distributed, symbolizing new beginnings and hope, thanks to the support of various contributors.

4th Cycle Distribution (Saturday, 24th February 2024): 31 sewing machines were distributed, capping off a successful year with continued support from donors, laying the groundwork for future empowerment.

RATION SUPPORT

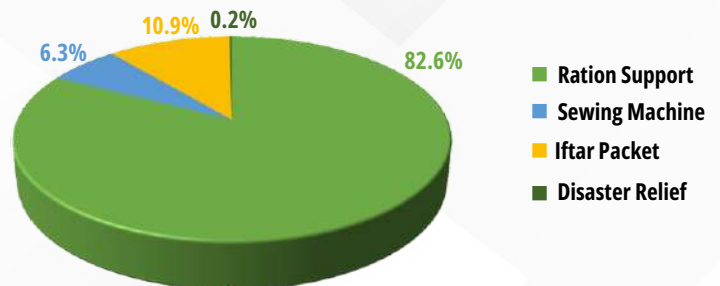
In March 2024, MESCO conducted three significant distributions of Ramzan kits across various locations:

Shabnum Ansari

Shabnum Ansari, a 35-year-old woman from Mumbai, has proven that with determination and hard work, one can overcome even the most difficult challenges. Shabnum never had formal education and struggled to make ends meet by doing stitching work from home.

Shabnum lives on a rental basis, paying Rs. 2500/- p.m. Due to financial constraints, she and her family live on an open terrace covered with plastic. Her household consists of three members: her 70-year-old mother, Rashid Ansari, and her 11-year-old son, Mohd Abbas Ansari, who is in the 5th standard with annual school fees of Rs. 10,000/-.

Two years ago, Shabnum moved to Mumbai to escape a long and stressful

divorce case that lasted nearly a decade in her village. The prolonged legal battles and financial struggles forced her to seek refuge in the city. Her brother helped her find accommodation and supported her financially, but Shabnum's dream was to become self-reliant through her stitching work.

At that time, the total family income was Rs. 5000/-. Medical expenses were 400 rupees, monthly rent was Rs. 2500/-, and Rs. 249/- were spent on a mobile phone, leaving very little for other needs.

However, Shabnum's life changed for the better when she received support from MESCO, who provided her with a sewing machine. With this help, Shabnum's income increased significantly. She now earns between Rs. 9000/- to 10,000/- a month by doing stitching work for a nearby garment company, making tops and dupattas.

Shabnum is now financially stable and no longer needs her brother's support. She manages all expenses on her own and takes pride in her hard work. Her story is a testament to resilience and perseverance, showing how support and determination can lead to a better life.

Shabnum expresses her gratitude to MESCO for the sewing machine that helped her achieve financial independence. She is a shining example of how, with the right support and unwavering effort, one can turn their life around.



Divya Chaurasia

Divya lost her father due to Cancer in 2010 unfortunately. Her mother is suffering from Post Polio Residual Paralysis. Life was an emotional roller coaster ride for Divya's family. Her elder sister is a graduate. The mother and daughters are running a stationery shop near their residence to make ends meet. Divya is a meritorious child but due to financial struggles, it was difficult for the mother to afford education expenses.

Divya has been proud recipient of a scholarship under the Education Adoption Scheme (EAS) since 2019 by MESCO when she was in Std. IX.

After analyzing the family's Socio-Economic conditions, the family has also been offered monthly Ration Support to ease out the food expenses. It is truly beneficial as the family's nutritional needs are also taken care of. Presently Divya is pursuing B Com. She has been performing excellently since she was a school kid. The setbacks in her life have fueled her determination to succeed. She is scheduled to be a graduate by May 2026.

NEWSPAPER COLLECTION

The Organization has been carrying out this activity since its inception. A classic example of how “each drop of water can make an ocean”. In the reporting year the organization collected 44809 kgs. of old newspapers through the City Unit (Bandra to South Mumbai & Chembur), 46784 kgs. of old newspaper through Suburb Unit (Khar to Borivali) and 22054 kgs. of old newspapers from Thane Unit (Thane, Navi-Mumbai & Mira Road). Apart from this, three Units were able to collect 84419 kgs. of Old Clothes and generated INR. 38.89 Lakhs by the sale of various scrap items. We are thankful to the 3270 donors, spread across 85 locations (2995 houses across 1450 housing societies & 7 Institutional Units) who have been supporting us and helping us carry out this activity year after year. Your contributions have aided in the growth and development of many deprived students.

NOTES TO ACCOUNTS

NOTES FORMING PART OF ACCOUNTS AS ON 31-03-2024 SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING:

- 1) The financial statements have been prepared in accordance with the historical cost convention in accordance with the generally accepted accounting principles in India and the applicable Accounting Standards issued by the Institute of Chartered Accountants of India.
- 2) All Income and Expenditure items in the financial statement are recognized on accrual basis.

B. USE OF ESTIMATE:

The preparation of the financial statements are in conformity with the significant accounting policies which require the management of the trust to make estimates and assumptions that affect the reported amounts of Income and Expenditure of the reporting period and the reported amount of assets and liabilities as on the reporting date. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods.

C. FIXED ASSETS:

Fixed Assets are stated at cost of acquisition, less accumulated depreciation. The cost of fixed assets includes the purchase cost and any other directly attributable costs of bringing the assets to their working condition for the intended use.

D. DEPRECIATION:

Depreciation is provided on the fixed assets under the written down Value method at the rates prescribed by Income Tax Act, 1961 & has been charged to the Income and Expenditure Account.

E. INVESTMENTS:

Investments of the trust comprise of fixed deposits and recurring deposits with banks and Mutual Funds stated at cost except for a case where donations have been received in the form of shares and disposed off during the year. The said shares were recorded at Fair Market Value as on the date of receipt of shares.

F. REVENUE RECOGNITION:

Donations are recognized on receipt basis. Donation received with a specific direction that they shall form part of the Corpus Fund of the Trust has been accounted accordingly. Interest income is accrued on a time proportion basis having regard to the amount outstanding and the rate applicable.

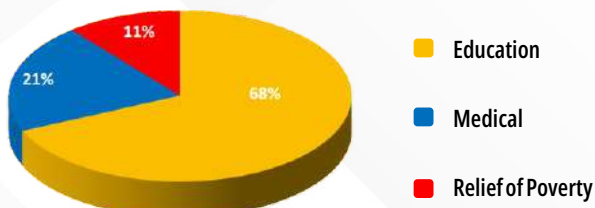

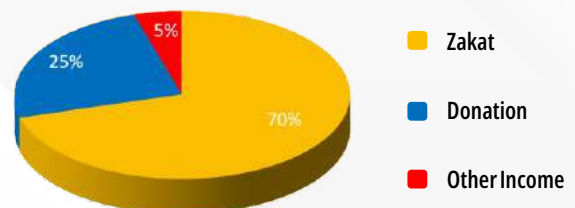
